MAGISTERIAL DECREE 05 / 2020

To all Dames and Knights, Brethren of
Our Sovereign Order of Saint John of Jerusalem
Knights of Malta
Federation of Autonomous Priories,
let it be known by the present letters that

We, José, by the Grace of God Hereditary Regent and Grand Chancellor of the Sovereign Order of Cyprus, Hereditary Grand Prior and Procurator General of the Grand Priory of the Most Holy Trinity of Villedieu and, by the Will of Our fellow Knights, Prince Grand Master and Head of State of Federation of Autonomous Priories of the Sovereign Order of Saint John of Jerusalem, also said of the Knights Hospitallers or of Malta, in virtue of the powers bestowed upon Us, namely the by the Articles nº 1 and nº 2 of Chapter III and of the Chapter VII of Our Constitutional Letter, and also as President of the Board of Directors and CEO of Femeraid International,

considering that the Hospitaller work is the fundamental and historical mission of Our Sovereign Order and of our State;

considering that Our institution dedicated to provide Medical Care and Humanitarian Assistance to the needy and to critical patients, called FEMERAID INTERNATIONAL, is in a constant process of evolution and of fast growth which constantly requires the creation of new institutes and Services to accommodate new branches and services of Medicine ;

considering that the use of natural medicines is growing very fast all over the World but the medical utility and efficacy of some of this products requires a serious scientific investigation and research, and that our Femeraid International can give a very serious and positive contribution in this matter;

Having had all the above stated facts in consideration and after having consulted with Our Prime Minister and Lieutenant General, as well as with other members of Our Government, and of the Board of Directors of Femeraid International, in accordance with the terms of Our Constitutional Letter,

We come to decree and We do decree:

ARTICLE 1. By the present Decree We create in the global structure of Femeraid International a new Institute called

**FEMERAID INTERNATIONAL INSTITUTE FOR
SCIENTIFIC RESEARCH ON NATURAL MEDICINE**

ARTICLE 2. The Institute aforementioned in Article 1. is NOT, can NOT and will NOT, now or in the future, be considered, styled or recognized as an Autonomous Entity, for any purposes whatsoever, since it is an integrant part and parcel of the structure of the Femeraid International, and as such can NOT, and will NOT exist out of its context .

ARTICLE 3. If, for any reason, whatsoever, the Institute created and constituted by Our present Decree will attempt to separate or to act without the knowledge and the consent of Our Magisterial House, and of the Board of Directors of Femeraid International, or act apart or independently from Femeraid International, from its Board of Directors or against their orders and instructions, its leaders, as well as all of the members supporting them, will automatically be dishonorably expelled from the Institute and accordingly to the seriousness of the situation, the Institute itself may be considered and declared by President of Femeraid International as extinct and dissolved, all this being valid from the day of the event on and with no right of appeal of any kind.

ARTICLE 4. The new Femeraid International Unit a is expected to act in accordance with the highest and more serious scientific and ethical standards for research and investigation.

ARTICLE 5. By the present Decree We come to appoint the respected scientist

ARTICLE 6. This new Institute of Femeraid International must be registered not only internally in KMFAP as a Femeraid International institution, but also as a NGO in the country of residence of its directors, in accordance with and fulfilling the requirements of the legislation of that country.

ARTICLE 7. The present Magisterial Decree is effective from this day on.

This decree, was given in two pages, at Our Magisterial House in Zejtun, Città Beland, Malta this 10th day of the month of April of the year of our Lord 2020 and to it We have hereunto set Our hand and the seals in use at this House .
